Japan's irreparable sin

Long-term boycott (go home campaign) impacted my taxi business.

6 Background of the Lawless-Hate

★Woman's mysterious act waiting on my way home.

③★Originally I don't know about women's mysterious act.

★⑤Woman don't have an active sexual desire.

I didn't know woman who have sexual desire, so I got it exceptive.

For example, prostitution is women.

People think they take money because they dislike sex.

⑥Women don't have sex easily.

Basically even if women feels good too, they have a risk of pregnancy.

⑦People don't have sex easily.

⑪ Sex is negative.

⑫ I'm married with kids, so I was unsure about ethics.

Originally am I a subject of the proverb?

★Considerations on proverb "Man must not refuse lady's advances."

From my experience, it seems to mean "When woman desires sex, man should always accept it."

I first heard it in middle school, but I couldn't understand it.

Originally I don't intend to rebel against this proverb, and there is accepted example.

Siege (illegal sharing) is always violent, so I simply resisted.

A No definition of "lady's advance"

We can't respond if don't find what it is.

B No basis for respecting in woman's case only.

"lady's advance" is almost under motivation.

Thus to belittle man's under motivation is gender discrimination.

Also, chastity cannot keep if woman often become "lady's advance".

C It ignores humanity.

D It ignores "type".
